

SLAUGHTER 2 SUCCESS ADOPTION AGREEMENT

EQUINE ADOPTION

This equine adoption agreement (hereby referred to as "Contract") is by and between Slaughter2Success Equine Rescue, a 501(c)3 organization dedicated to the rescue of equines (hereby referred to as "S2S"), whose principal address is 2330 Turner Ave. Solon IA, 52333 and _____ (hereby referred to as "Adopter"), whose principal address is _____. The signing of this contract shall mark the agreement of S2S to give ownership of equine to the adopter as per the terms and conditions of this contract.

2. ADOPTION FEE

The adopter shall pay a nonrefundable fee of \$_____ at the time of adoption.

3. CARE AND KEEPING

The adopter agrees to provide humane and responsible treatment to the equine at all times and shall take sole responsibility for providing necessary nutrition, clean water, adequate shelter, reasonable opportunity for exercise, and all necessary veterinary care including yearly vaccinations and dental examinations. Should the equine become sick or injured, the adopter

agrees to provide immediate medical care by a licensed veterinarian, and the adopter shall take full financial responsibility for the medical care provided.

4. AUCTION CLAUSE

Under no circumstance shall this equine be sold at an auction at which slaughter buyers are present. Adopter agrees to take full responsibility for the prevention of such circumstances.

5. RE-SURRENDER POLICY

If at any point the adopter wishes to re-surrender the equine, minimum 14 days notice to S2S is required.

6. ALTERNATE HOME

Should the adopter wish to find an alternate home for the equine within the first year of purchase, S2S requires written notification of such a change as well as an opportunity to independently assess such an alternative home with an understanding that S2S representatives must remain apprised of living conditions and plans for all rescue horses whose rehome S2S has managed.

7. REPRESENTATION OR GUARANTEE

S2S representatives, employees, or agents make no representation or guarantee for the health, training, temperamental, mental disposition, or precise age of the equine.

8. RELEASE OF LIABILITY

The Adopter agrees never to file a claim or suit against S2S. The Adopter releases S2S and its founders, employees, agents, representation, volunteers, and assigns from any liability arising from the pet's adoption.

9. INDEMNITY

The Adopter agrees to indemnify and hold S2S harmless for any injury, illness, amputation, scarring, death, damages, or other losses to the equine, arising out as a result of the Adopter's negligence or liability.

10. MISCELLANEOUS

- a) **Modification:** No modification of this Contract shall be made unless in writing, signed by both parties.
- a) **Governing Law:** This Contract shall be construed by and in accordance with the laws of Iowa.
- b) **Legal and Binding Contract:** This Contract is legal and binding between the Parties as stated above. This Contract may be entered into and is legal and binding in the state

of Iowa. The Parties each represent that they have the authority to enter into this Contract.

- c) Entire Agreement: This Contract constitutes the entire Contract of the parties. No representations, promises, terms, conditions, obligations, or warranties whatsoever referring to the subject matter hereof, other than those expressly set forth herein, shall be of binding legal force or effect.

Each party is signing this agreement on the date stated opposite that party's signature.
